1.	What are the documents that will confirm that the prospective bidder is an import and export company or freight forwarder in the Philippines?	Any of the following documents:
	Can we submit a CAB (Civil Aeronautics Board) Certification? CAB is being secured by Freight Forwarders from Department of Transportation. It is a certification that a company is licensed to operate via Air and logistics.	Please refer to No. 1
	Is FTEB (Fair Trade Enforcer Bureau) sufficient as license to operate? FTEB is a certification issued by Department of Trade and Industry. It is one of the certifications from logistics company	Please refer to No. 1
4.	To appear in all documents would be CITEM, right?	CITEM or DFA, either to be accorded diplomatic immunity
5.	Is this considered as diplomat shipment?	The shipment will be accorded diplomatic immunity
6.	Regarding packaging, is the basket and packaging included in Php 1,200.00?	The Php 1,200.00 is the minimum budget for the products only Baskets will be provided by another company.
7.	Is the Material Safety Data Sheet of Rum is available?	Yes. We will endorse you to the product manufacturers for all the necessary documentary requirements
8.	Since there are chocolate components in the shipment, do we have a study that this will not melt during shipping by sea?	Chocolates will have to be shipped via air.
