付款细则 Rules of Payment

The exhibitor shall pay [100.00] % of the total booth fee before [May] [31], [2021].

● The exhibitor may pay the booth fees agreed hereunder to the Organizer via bank transfer, overseas wire transfer, etc.

参展须知:

1. 参展单位承诺提交的所有材料的合法性、真实性和有效性。参展单位提交参展合同前请仔细阅读并遵守《参展条款细则》，该细则构成参展合同不可分割的一部分，与参展合同具有同等法律效力，详见官网(www.cicie.org)“企业商业展”栏目下的“下载专区”。
2. 参展单位不得有下列任一行为：未经展会方书面同意将本合同所约定的权利义务全部或部分向第三方转让或与第三方共享；现场零售或提供有偿服务；展出的展品超出参展展品清单范围；未经授权展出第三方产品；侵犯他人的知识产权等合法权益；其他违约违规行为。如违反上述任一行为，展会方有权采取包括但不限于勒令停止违规行为、移走或暂扣或驱逐违规展品、注销参展单位和相关第三方的证件并拒绝其参加本届进博会，情节严重的，拒绝参展单位及其关联企业在未来三年内参加进博会等相关措施。
3. 参展单位委托第三方代签参展合同及其他相关文件的，须向展会方提供相应的授权委托书。展会方收到参展单位(或其授权代理人)盖章的参展合同后，将审核相关资料。展会方在审核通过后签署并返还参展合同。参展合同的扫描件或传真件与原文件具有同等法律效力。
4. 展会方同意参展单位委托 (受托付款单位全称) (以下简称“受托付款方”)完成参展合同约定的付款义务，参展单位保证受托付款方向展会方出具《承诺函》并代为履行付款义务。如受托付款方未按照约定付款，不视为免除参展单位的付款义务。
5. 根据参展单位的付款情况，展会方可在展位、广告、证件、酒店等方面优先予以安排。参展单位或其受托付款方未能按照前述付款细则的约定支付参展费用，延迟付款10个工作日及以上的，或未付款(含未足额付款)且未及时以书面形式通知展会方的，展会方有权终止参展合同并将相应展位另做安排，已经支付的展位费不予退还。
6. 参展单位因故无法参展，应向展会方提出书面退展申请并取得其同意。经展会方同意后，参展单位于2021年3月31日前提出退展申请的，展会方可将实际收取展位费全额退还(不计利息)；于2021年4月1日至2021年6月30日期间提出退展申请的，展会方有权扣除实际收取展位费的25%；如超过2021年7月1日提出退展申请，已收取的展位费概不退还。
7. 如参展单位推荐未参加过中国国际进口博览会的企业实际参展，参展单位可获得被推荐参展企业展位费的相应比例作为消费额度，符合展会方条件的，参展单位的消费额度可用于抵扣与进口博览会展位、论坛、活动、酒店、广告等相关的费用，展会方对上述内容具有最终解释权。
8. 展会方有权根据最终实际报名情况、展会规模、特点等因素，对展位位置和面积、展览场地整体或局部布局进行调整。如因此导致参展单位被取消参展资格，展会方将实际收取的展位费退还至付款账户(不计利息)；如因导致参展单位展位面积缩小，展会方将向付款账户退还因参展单位展位面积的缩减而产生的展位费差额(不计利息)；除此外，展会方不承担其他责任。
9. 参展合同所指时间均为北京时间，所涉及的付款时间是到账日，且以款项到达展会方账户为准。付款数额以展会方实收金额为准。因付款所产生的各项费用应由参展单位承担。
10. 参展合同展位分为：标准展位(9 m²/个)：由展会方统一形象搭建；光地展位(36 m²起订)：参展单位自行承担展位设计、展位搭建及相关费用。展会方仅提供场地、公共区域的基本照明和清洁。

Participation Notice:

1. The exhibitor makes commitment that all the materials submitted is legitimate, authentic and valid. The exhibitor shall thoroughly read and comply with the Detailed Rules of Exhibition (which forms an integral part of this contract with same legal effect as this contract, for details please refer to the "Download" under the "Business Exhibition" Column at the Official Website (www.cicie.org) before submitting this contract.)
2. The exhibitor shall not have one of the following: assign to or share with any third parties all or part of its rights and obligations agreed herein, sale or provide payable service, show the exhibits outside of the list of exhibits, show the exhibits of third party without lawful authorization, infringe on the others IP rights or other lawful rights and interests, the other breach or violation of contract or laws and regulations. Otherwise, the Organizer shall reserve the right to take the following measures, including but not limited to stopping the breach or violation, having the unconfirmed exhibits temporarily distrained, removed, covered, canceling the certificates of the exhibitor or related third party and refuse their participation. In case of serious situation, the Organizer is entitled to refuse the exhibitor and its affiliated enterprises to participate in the next three CHEs and the other measures.
3. If any third party is entrusted by the exhibitor to sign the Participation Contract and other related documents, the exhibitor shall present a Letter of Authorization to the Organizer. Upon receipt of the Participation Contract signed and sealed by the exhibitor (or its authorized agent), the Organizer should review relevant documents and return the endorsed Participation Contract upon approval. The scanned or faxed copies of the original papers shall have the same legal effect as the original ones.
4. The Organizer agrees the exhibitor to entrust (hereinafter referred to as the "entrusted payer") to fulfill the payment obligations as stipulated in this Contract; the exhibitor guarantees that the entrusted payer presents a Commitment Letter to the Organizer and fulfills the payment obligations on its behalf. Where the entrusted payer does not make payment to the Organizer as agreed herein, the exhibitor shall not be deemed exempt from corresponding payment obligations.
5. The Organizer may make preferential arrangement for booth, advertising, ticket or certificate, hotel and the others for the exhibitor in accordance with its status of payment. Where the exhibitor or the entrusted payer fails to pay exhibition fee, after a deferral for up to ten workdays or more, or no payment (including partial payment) without timely notifying the Organizer in writing, the Organizer shall be entitled to terminate the Participation Contract and re-arrange the corresponding booth and the booth fee already paid (if any) shall not be refunded.
6. The exhibitor failing to participate in the exhibition for any special reasons shall put forward the written application for withdrawal from the exhibition and obtain the consent of the Organizer. After obtaining the consent of the Organizer, the Organizer may have the booth fees (without interest) received actually refunded in full, if the application is put forward prior to March 31, 2021, otherwise the Organizer shall be entitled to deduct the 25% of the booth fees received actually, if put forward from April 1, 2021 to June 30, 2021 and all booth fees received actually shall not be refunded if later than July 1, 2021.
7. The exhibitor which recommend the enterprise which did not participated in the the exhibition to actually participate in the exhibition may enjoy a consumption quota at corresponding proportion of the booth fees paid by the recommended enterprises, if the conditions of the Organizer are satisfied, the consumption quota may be used to deduct the fees with respect to the booth, forum, event, hotel, advertising, etc, the power of final interpretation belong to the Organizer.
8. The Organizer shall be entitled to timely adjust the location and area of booths according to the actual applications, exhibition scale, features or to adjust the exhibition overall layout in full or in part. If the exhibitor's participation qualification is canceled due to such adjustment, the Organizer will return the booth fees paid to the original paying account of payment (free of interest); if the area of booth is reduced therefrom, the Organizer will return the difference (free of interest) arising from the area deduction to the original paying account of payment without bearing any liability.
9. The time under this contract is China Standard Time (CST) and the time of payment refers to the date of the payment reaching the designated account of the Organizer. The payment amount shall be subject to the actual sum received by the Organizer. All expenses incurred due to payment shall be borne by the exhibitor.
10. The booth herein is classified as Standard Booth (9 m²/booth), which shall be designed and constructed by the Organizer and Raw Space (Min. 36 m²): which shall be designed, constructed and decorated by the exhibitor at his own expenses. The raw space booth fee only covers the raw space allocation, lighting and cleaning for the public area provided by the Organizer.
